1.	Time of completion of 18 months is too less -as compared to the estimated cost. We may have to remove pre-laid services like electric cable, sewer line, water line, telephone cable etc. moreover, it is quite possible that the sub-soil water level might be higher than the bottom level of foundation, as such pumping of the sub-soil water might be undertaken which is a time consuming process. Therefore, we request that the time of completion should be at least 24 months.	As per tender Conditions.
2.	Strata Chart -is not enclosed as such we do not have a clear knowledge of the sub-soil water level or the soil profile.	As per tender Conditions.
3.	Local Approval :-has the building been approved by local authorities to start the work, otherwise it may take months to get such approvals, which will inadvertently lead to delay in the progress of work. Moreover, who shall pay for such charges i.e. approval of electric connection , water connection etc.	As per tender Conditions.
4.	As per page no. 14 para 1.6 of the NIT; is the full site available for work or will it be provided in stages.	As per tender Conditions.
