1.	<p>Sluicing machine cum Washer extractor : This is a special purpose machine (SPM) which has an application of defence against the spreading of micro-organisms and cross infections. But in your tender if you see the item no. 1,2,3 the specifications are 100 % identical We want to ask you how a SPM has the same specifications of a normal machine? To control the spread of infectious micro-organisms/Bacteria a Hygiene Barrier Washer is required</p>	Tender terms prevail.
2.	<p>Flatwork Ironer Roller/ Chest heated In the technical specifications you have mentioned two different technologies i.e. one is chest heated and another is roller heated. You would know that many micro-organisms do not die while washing in hot water as this Micro organism (MO) even resist 100 degrees of temperature which is not possible in wet washing. To kill these MO the temperature on the surface should be more than 140-160 degrees i.e 160-180 degrees on the probe or the sensor.</p> <p>Also to get a longer life the contact heated surface chest/roller depending on whatever technology required should be atleast made of SS304.</p> <p>Also the output speed mentioned is 2-6 meters per minute which is very confusing, as it should be not less than a specific speed i.e the output of the linen ironed/dry through this flatwork ironer should not be less than 6 meters/minute.</p> <p>Also internationally flatwork ironer are 800 Dia We would like to ask you why you have chosen this ironer of 500 Dia which is only manufactured by some</p>	<p>Tender terms prevail</p> <p>Tender terms prevail.</p> <p>Tender terms prevail.</p> <p>Flat Ironer shall be 500/800 dia.</p>

	<p>local manufacturers.</p> <p>Also by choosing this ironer we have not only chosen to give lesser contact to heated surface, as contact angle in Chest heated is 180 degree and roller heated is 270 degree. We request you to kindly consider to amend this from 500 Dia to 800 Dia.</p>	
3.	<p>We also recommend that the main machine i.e washer extractor, Flatwork ironer, & Tumble dryer must be CE marked from a notified agencies. As you would know many suppliers are running with fake CE certificates.</p>	Tender terms prevail.
