1) The Clause "1" at Page 6 of "Information and Instructions for Bidders for E-Tendering Forming Part of Bid Document" is amended as follows:

As per Existing Provision

- 1. Firms who fulfill the following requirements shall be eligible to apply:
 - Should have satisfactorily completed similar EIA Study (Building and Large Construction Projects) during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following;

One similar completed works of Environmental Impact Assessment study in India consisting not less than the amount equal to 80% of estimated cost.

(or)

Two similar completed works of Environmental Impact Assessment study in India area consisting not less than the amount equal to 60% of estimated cost.

(or)

Three similar completed works of Environmental Impact Assessment study in India area consisting not less than the amount equal to 40% of estimated cost.

Similar work shall mean the work of Consultancy for Environmental Impact Assessment Study of Building & Large Construction Projects.

As per Amendment

- 1. Firms who fulfill the following requirements shall be eligible to apply:
- i. Should have relevant experience in Environmental Consultancy (Environmental Impact Assessment and/or NBWL Clearance and/or Consent to Establish under Air and Water act) of Building or Large Construction Projects during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following;

One similar completed work consisting not less than the amount equal to 80% of estimated cost.

(or)

Two similar completed works consisting not less than the amount equal to 60% of estimated cost.

(or)

Three similar completed works consisting not less than the amount equal to 40% of estimated cost.

Similar work shall mean having relevant experience in Environmental Consultancy (Environmental Impact Assessment and/or NBWL Clearance and/or Consent to Establish under Air and Water act) of Building or Large Construction Projects.



2) The Clause "3" Information Required for Prequalification" at Page 12 of "General Conditions of Contract" is amended as follows:

As per Existing Provision

Bid submitted shall include the following information:

- ii. Experience of having successfully completed similar EIA Study (Building and Large Construction Projects) during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following;
 - a. One similar completed works of Environmental Impact Assessment study in India consisting not less than the amount equal to 80% of estimated cost.

Or

b. Two similar completed works of Environmental Impact Assessment study in India consisting not less than the amount equal to 60% of estimated cost.

Or

c. Three similar completed works of Environmental Impact Assessment study in India area consisting not less than the amount equal to 40% of estimated cost.

As per Amendment

Bid submitted shall include the following information:

- ii. Should have relevant experience in Environmental Consultancy (Environmental Impact Assessment and/or NBWL Clearance and/or Consent to Establish under Air and Water act) of Building or Large Construction Projects during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following;
 - a. One similar completed work consisting not less than the amount equal to 80% of estimated cost.

Or

b. Two similar completed consisting not less than the amount equal to 60% of estimated cost.

Or

c. Three similar completed consisting not less than the amount equal to 40% of estimated cost.

Similar work shall mean having relevant experience in Environmental Consultancy (Environmental Impact Assessment and/or NBWL Clearance and/or Consent to Establish under Air and Water act) of Building or Large Construction Projects.

All other terms & Conditions of the Tender shall remain unchanged.
