(2) Refer Cl. No. 2.0. "Minimum Eligibility Criteria" of Vol.-I (NIT & PQ) is amended as follows:

- ii) (I) Should have satisfactorily completed the following works in India during Seven (7) years ending previous day of last date of submission of tenders:
- a. Three *Similar completed works each costing not less than 40% of the estimated cost put to tender.

OR

b. Two *Similar completed works each costing not less than 60% of the estimated cost put to tender.

OR

c. One *Similar completed work costing not less than 80% of the estimated cost put to tender.

*Similar Work" shall mean Project comprising "Construction of any RCC/ composite framed structure building including finishing works, internal water supply, sanitary installations & internal electrical installations, firefighting works and HVAC works all executed under one composite agreement/work order.

NOTE:

- a) Godowns/Warehouses/Factory sheds/Industrial building shall not be considered as eligible similar works.
- b) Mumty and Machine room shall not be considered in storey.
- c) Each Basement, Stilt constructed in the building shall be considered as a storey.

AND

(II) Additional qualifying criteria:-

The bidder should have successfully completed one work (either part of (ii)(I) above or a separate one) as mentioned below during the last 7 years ending previous day of last date of submission of tenders:

"Hospital Project of minimum capacity of 50 beds"

- **ii**) (I) Should have satisfactorily completed the following works in India during Seven (7) years ending previous day of last date of submission of tenders:
 - a. Three *Similar completed works each costing not less than 40% of the estimated cost put to tender.

OR

b. *Two *Similar completed works each costing not less than 60% of the estimated cost put to tender.*

OR

c. One *Similar completed work costing not less than 80% of the estimated cost put to tender.

***Similar Work**" shall mean Project comprising "Construction of any RCC/ composite framed structure building including finishing works, internal water supply, sanitary installations & internal electrical installations and firefighting works all executed under one composite agreement/work order.

NOTE:

- d) Godowns/Warehouses/Factory sheds/Industrial building shall not be considered as eligible similar works.
- e) Mumty and Machine room shall not be considered in storey.
- f) Each Basement, Stilt constructed in the building shall be considered as a storey.

(II) Additional qualifying criteria:-

The bidder should have successfully completed one work (either part of (ii)(I) above or a separate one) as mentioned below during the last 7 years ending previous day of last date of submission of tenders:

"Hospital Project of minimum capacity of 50 beds"



(3) The validity of Bid Security/ Earnest Money Deposit (EMD) to be submitted by the bidders with their bid in the form of Bank Guarantee (BG) shall be considered from the original due date of bid submission i.e., from 28.12.2023

All other terms & Conditions of the Tender shall remain unchanged.
