12.	As per clause no.42.2.5 of SCC, we understand that we have to provide site office to Client. Kindly provide us a typical plan for such office along with the details of the facilities required.	Shall be as per Tender conditions.
13.	As per item no.16.01 for Electrical work of BOQ, it has been mentioned that the speed of the lift should be from 0.5 mps to 1 mps. However, since it is not possible to have lift speed varying within the given speed range, hence we request you to confirm the speed of the lift.	Shall be as per Tender conditions. Speed must be of 0.5 mps to 1.0 mps as per the manufacturers specification for the lift mentioned in the BOQ

Provided always that the total amount of compensation for delay to be paid under this condition shall not exceed 10% of the tendered value of the item or group of items of work for which a separate period of completion is originally given. Request for maximum 5% of the Contract value.	Shall be as per Tender conditions.
17.	GCC Page no.42: Water supply – The contractor(s) shall provide adequate supply of water for the use of labourers. The provision shall not be less than two gallons of puree and wholesome water per head per day for drinking purposes.; Request for water line connection from CMC because borewell not permitted in KMC area.
