	The above clause stipulates that "A certificate from client for completion of similar works along with work order must be submitted by bidder for each work order along with application. "Own works/work under the same management/own certificate of the bidders shall not be considered for prequalification."	I
	We find that the eligibility criteria published in your tender document is identical to CPWD, (GOI) Tender expect the specific clause highlighted above.	
	You will appreciate our concern that by introducing this clause, completion shall be restricted to limited bidders and Government may lose competitive price bids. Hence you are requested to allow CPWD norms of eligibility and consider own works/work under the same management if the eligible works are duly supported by relevant documents i.e. completion certificate, TDS, work order as prevalent in Government Tenders such as NBCC, DDA etc.
