Also you have added the some of the equipment in this tender like instrument trays, RO water, sterile containers with good quantity and etc. this also need to enhance the budget so please look into the matter and enhance the budget of 1.5 more Crore excluding CMC from current budget of 6 crore. i.e. approx. 7.5 Crore excluding cmc.
