Following locations inside National Cancer Institute (NCI) campus, Badsa, Jhajjar, Haryana are proposed for installation of solar panels on space frames of proposed suitable height:

The space frame at point (c) is proposed at 20 feet height so that area under it can be utilized for patient related services.

#### 2. Role/ Scope of work

The scope of work includes supply, installation, testing, commissioning, operation and maintenance of 10 MWp Solar Power Plant of RESCO (Renewable Energy Service Company) model at National Cancer Institute, Badsa, Jhajjar, Haryana

The applicant should visit the site and make an assessment of the job based on the availability of land. A tentative location for proposed solar power plant has been marked on Master plan of the campus and enclosed at Annexure III.


