INSTRUCTIONS TO BIDDERS

No editing, addition/deletion of matter is permitted. If such action is observed at any stage, such tenders are liable for outright rejection.

2. The bidder has to submit an earnest money of Rs.**5000**/- along with bid in shape of demand draft of a scheduled bank issued in favour of HSCC India Limited payable at Delhi/ Noida. Any bid not accompanied with EMD shall reject. EMD of the bidder shall be returned within 20 days after the finalization of tender. No interest will be paid by the HSCC on the EMD.

3. Only enclosed formats as provided in original should be used. All sheets need to be submitted **after affixing seal of the Company and signature of the authorized signatory**. Additional sheets, duty authenticated, may be attached to elucidate specifications or clarify the specific issues.

7. Supplier should be authorize distributor /partner/dealer of the OEM for the Firewall.

7. The bidder shall quote the prices in INR of goods and services inclusive of all duties and all taxes, duties, freight, levies, or charges. The supplier will be entirely responsible for all taxes, duties, licenses fee, octroi, road permit fee etc. in connection with delivery of the Firewall at HSCC office at Noida.

5. The Bidder shall submit a manufacturers (OEMs) letter of authorizations (as per attached Annexure III for this particular tender) for Firewall.
