- 2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.
- 3. Forms of EMD and PBG Bidders can also submit the EMD with Account Payee Demand Draft in favour of HSCC (I) Ltd. payable at Noida. Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

Payment OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted st aff deployed at buyer location first i.e. on their own and then claim payment from Buyer 5 / 7 alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.
- 7. Past Project Experience Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
  - **a**. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies agains t the invoices have been executed.

- 10. The agency or contractor shall be solely responsible for the 24x7 hours security of the HSCC Office s, Sector, 1, Noida, U.P. by deploying manpower and tools and machines etc. and shall be carried out as per BOQ/ scope of work/ bid documents. Material/equipment's/tools required for the 24x7 hours security of the HSCC Offices/ Complex / Plot /Store is included in the scope of this work. Nothing ex tra shall be paid to the contractor by HSCC .The contractor or agency shall provide sufficient quantity of manpower at site as per contract with complete bio-data to meet with requirement security servic es on 24x7 hour basis of the HSCC Offices/ Complex / Plot /Store and as per scope of work and direction of HSCC.

#### 11. MINIMUM WAGES

It shall be the responsibility of contractor to pay minimum wages to the workers as applica ble/ revised time to time during the tenure of the contract (Central or state govt . minimum wage s whichever is higher) . This tender is prepared on the basis of Central Govt. minimum wages applicable on the date of publication of this tender.

However, any increase or decrease in applicable minimum wages by the Government during the tenure of the project shall be reimbursed/ deducted with/ from the monthly bills of the contractor based on the applicability of revised rates and on production of suitable evidences as per the nor ms.

#### 12. BIOMETRIC ATTENDANCE

The contractor shall install a Biometric Attendance Machine for his workforce and attendance record to be given with the monthly RA bill. List of staff being posted to be given with their experience and credentials.

#### 13. COMPLETION PERIOD

The duration of contract will be 12 months from the date of start of work extendable upto twelve (12) months at the sole discretion of HSCC (India) Ltd.. if it is fully satisfied with the performance of the agency and if it is required by HSCC (I) ltd. However, HSCC (India) Ltd.. has a right under this contract to foreclose the contract at any time without giving any justification to contractor. The contract can also be terminated by HSCC (India) Ltd. by giving one month notice at any time. However, the agency has to continue its work with due diligence during the termination notice period, if any, given by HSCC (I) Ltd. No claim whatsoever in this regard shall be entertained by HSCC (I) ltd.

- 14. In case the agency fails to abide by any of the conditions of contract a financial penalty per ever y default as decided by HSCC (I) ltd. management will be imposed and binding upon contractor.
- 15. For non-compliance or partial compliance of execution of items, the Engineer-in-charge reserves his rights to levy compensation in accordance with the scale of non-conformity and the period for which this non-conformity continues. However the total amount of this compensation for the who le contract shall not exceed 10% of the tendered value of this contract. This shall be without prej udice to other remedies available to Engineer-in-charge under this contract to take action agains t the contractor.
- 16. Contractor shall be fully responsible for any damages caused to Govt. property by him or his lab ourers in carrying out the work and shall be made good by the contractor at his own cost.
- 17. The contractor shall responsible for all statutory compliances applicable for this work like EPF, ESI C, Minimum Wages etc. Besides contractor will be fully responsible for any of statutory complianc es imposed by the Govt. authorities in due course of contract or even extended period if anywithing his quoted rate and nothing extra shall be paid.
- 18. The agency shall give the liveries immediately to the all workers at his own cost as per followin q details:-

- a) Terricoat cloth of approved colour: 2 set of stitched pant and full sleeve shirt every year & cap
- b) One pair Leather shoes with socks. Once in a year.
- c) Woollen sweater once in a year.
- 19. In case of any dispute in interpretation of conditions of contract then special conditions of contract will prevail and further decision of HSCC shall be final and binding on the contractor and no c laim whatsoever in this regard shall be entertained/payable to the contractor.
- 20. The agency shall deposit the EPF and ESIC on monthly basis and deposit amount online proof of deposit must be shown.
- 21. The contractor shall be responsible for police verification of their staff deployed for security ser vice.
- 22. The rates/ amount quoted by the bidders/ firms shall be considers as excluding of GST.
- 23. GST is payable on reverse charge (GST is payable by recipient of service i.e. HSCC).
- 24. Minimum wages of Govt. of India & others applicable benefit will be paid by Bidder/ agency as p er the current norms. Ministry of Labour & Employment, Govt. of India, New Delhi office order F ile no. 1/5(6)/2023-LS-II dated 03/04/2023 regrading minimum wages is enclosed.
- 25. All the financial Bids shall then be ranked according to the financial Bid in increasing order with the Bidder quoting the least amount ranked L1, Bidder quoting next higher figure as L2 and so o n. The overall quoted amount shall be considered for evaluation and the work will be awarded to bidder, who has quoted overall lowest rates.
- 26. HSCC shall mean HSCC (India) Ltd./ HSCC (I) Ltd., having corporate office at E-6(A), Sector-1, N oida, U.P. 201301
- 27. The contract can also be terminated by HSCC (India) Ltd. by giving one month notice at any tim e if the performance of the agency is not satisfactory and his performance bank guarantee will al so be forfeited. Besides, the agency may be debarred from business dealing with HSCC (India) L td. for next 2 years from the date of issue of Notice of debarring.

### Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
