# Special terms and conditions-Version:3 effective from 11-11-2022 for category Ophthalmic Operating Microscopes

- All Provisions of Drugs and Cosmetics Act, 1940 and Rules made there under as amended till date will always be applicable. This will include all notifications issued by *Central Drugs Standard Control Organisation(CDSCO)*, Ministry of Health & Family Welfare (MoHFW) and Department of Pharmaceuticals (DOP), Ministry of Chemicals & Fertilizers time to time in this regard.
  - 2. The sellers are registered on GeM based on self-declaration of valid Drug License, product certification, test reports etc. However, buyers must check and validate the details at their end for all applicable licenses and certifications e.g., validity and authenticity/genuineness of drug license, product certification, manufacturer certification/licenses, test reports etc.
  - 3. The price offered by the seller shall not, in any case exceed the DPCO controlled price, if any, fixed by the Central/State Government, the Maximum Retail Price (MRP) and the selling price. The seller must reduce the prices if there is any reduction in DPCO ceiling price, if any.
  - 4. **Comprehensive warranty:** Comprehensive warranty shall include preventive maintenance including calibration as per technical/ service /operational manual of the manufacturer, service charges and spares. During the warranty period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee site as recommended in the manufacturer's technical/ service /operational manual, at least once in six months. warranty shall not be including the consumables. Further there will be 98% uptime warranty during warranty period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend warranty period by double the downtime period.
  - 5. Service centres: Details of Service outlets in India to render services for equipment to be furnished

to buyer/consignees with complete address,telephone numbers, e mails etc at time of making the supplies. It shall be the responsibility of seller to ensure that authorized service centres are available to cater to the areas where supplies are made within reasonable distance from where the service calls can be handled.Details of toll-free numbers for service call and online registration of service requests also to be provided buyer/consignee at the time of supplies.

- 6. **Source of supply:** It shall be responsibility of seller to provide Documents regarding source of equipments such as copy of Performa invoice or any other documents to establish that the products supplied are manufactured by OEM indicated and sourced from them.
- 7. **Packing and Marking:** Medical equipments being very delicate and sensitive packing for the goods should be strong and durable enough to withstand transit including transhipment (if any), rough handling, open storage etc. without any damage, deterioration etc. .The size, weights and volumes of the packing cases, remoteness of the final destination of the goods, availability or otherwise of transport and handling facilities at all points during transit up to final destination,. Quality of packing, the manner of marking within & outside the packages and provision of accompanying documentation shall take into consideration the type of medical equipments being supplied. The accessories shall be suitably labelled and packed. Each of the package shall be marked on three sides with indelible paint of proper quality: indicating contract number and date, brief description of goods including quantity, Packing list reference number, country of origin of goods and any other relevant details.
- 8. **Spare Parts:** Seller shall provide materials, information etc. pertaining to spare parts manufactured and supplied by the OEM. It shall be ensured that the required spares are available for purchase at least for 10 years from date of supplies. In case due to any reasons the production of the spare parts is discontinued sufficient advance notice should be given to the buyer/consignee before such discontinuation to provide adequate time to purchase the required spare parts etc. Further, OEM and their service centres/dealers shall carry sufficient inventories to assure ex-stock supply of consumables and spares for the equipments so that the same are available.

OEM or reseller shall always accord most favoured client status to the buyer/consignee and shall give the most competitive price for spares and consumables of its machines/equipments supplied.

- 9. Installation, Training, Manuals: Seller shall be responsible to carry out Installation & commissioning, Supervision and Demonstration of the goods. They shall provide required jigs and tools for assembly, minor civil works for the completion of the installation and Training of Consignee's representatives for operating and maintaining the equipment and supplying required number of operation & maintenance manual for the goods. In case the category parameters are specifying any requirements regarding the installations, training and manuals the same shall also be applicable.
- 10. Electrical safety checking: Sellers are required to make sure that they furnish the list of equipments for carrying out routine and preventive maintenance to buyer/consignee .They should make sure to periodically check the electrical safety aspects as per BIS Safety Standards or equivalent .In case they do not have required equipment for such testing should ensure that the equipments checked for electrical safety compliance through labs with facilities for such checking during every preventive maintenance call.

- (i) "BUYER/Purchaser/Client/Principal Employer/Employer/ Consignee" mea ns Director, Lady Hardinge Medical College & Associated Hospitals (LHMC ), New Delhi under Ministry of Health &Family Welfare, Govt. of India
- (ii) **"Consultant**" means **HSCC (I) Limited** subsidiary of NBCC under Ministry of Ur ban Development, Government of India, appointed by the BUYER.
- (iii) "Tender" means Bids / Tender received from a Firm / Tenderer / Bidder.
- (iv) "Tenderer" means Bidder/ the Individual or Firm submitting Bids /Tender.
- (v) **"SELLER/SERVICE PROVIDER/** Supplier" means the individual or the firm supplying the goods and services as incorporated in the contract.
- (vi) "Goods" means the articles, material, commodities, livestock, furniture, fixtures, raw material, spares, instruments, machinery, equipment, medical equipment, indu strial plant etc. which the supplier is required to supply to the purchaser under the contract.
- (vii) "Services" means services allied and incidental to the supply of goods, such as tr ansportation, installation, commissioning, provision of technical assistance, trainin g, after sales service, maintenance service and other such obligations of the suppli er covered under the contract.
- (viii) "Contract" means the written agreement entered by and between the purchaser

represented by consultant and the supplier, together with all the documents menti oned therein and including all attachments, annexure etc. therein.

- (ix) "Performance Security" means monetary or financial guarantee to be furnished by the successful tenderer for due performance of the contract placed on it. Perfor mance Security is also known as Security Deposit.
- (xi) "Specification" means the technical specification/standard that prescribes the re quirement with which goods or service has to conform, which are mentioned in the bid document.
- (xii) "Inspection" means pre delivery and /or post-delivery inspection to check the te chnical specification of Goods.
- 2. An agent submits bid on behalf of one Principal / OEM only, the same agent shall not submit a bid on behalf of another Principal / OEM in the same tender for the same item / product.
  - 3. One Bid per Bidder: An OEM can either participate directly or can only authorize one bidder t o quote on their behalf. In case of submission of multiple bids by an OEM, directly or through its authorized agent(s), all such **bids are liable to be rejected.**
- 4. Bid validity period: 180 days from the date of techno commercial bid opening.

- 7. Cost of equipment ware house to consignee including all costs , turnkey work cost if applicable and CMC will be added for Ranking/Evaluation purpose.
- 8. Bidder shall visit LHMC site before quote and must take into consideration in its bid, costs to be inc urred for any additional work pertaining to civil, Electrical, Plumbing, sanitary, Radiation protection as per Govt. regulation/or equivalent as per local statutory conditions , server, stabilizers, U.P.S. etc. if required for successful installation testing and commissioning of the system/ equipment shall be in cluded in the "All-inclusive lump sum price"/ turnkey work.
- 9. The pre delivery inspection may be carried out by third party Inspection agency viz LLOYDS/S GS /Bureau Veritas/ TUV or any other with same high status inspection agency before shipment of goods. The suppler shall arrange III party Inspection agency approved by HSCC. All charges for III party inspection shall be borne by the supplier.

The Purchaser/**LHMC** reserves the right to ask for a free demonstration of the quoted equipment at a pre-determined place acceptable to the purchaser for technical acceptability as per the tender spe cifications.

- 10. Delivery Period:90 days from date of Notification of Award/Purchase order to delivery at consignee site.
- 11. Installation and commissioning: Installation and commissioning shall be done within 60 days

of receipt of the stores/ goods at site or within **60 days** of handing over the site for installation, whi chever is later.

- 12. The Time taken for HSCC approval/ **LHMC -Delhi** approval / local statutory approval/eLORA (AERB) / issue of CDEC /DSIR Certificate/ Dispatch Clearance/note will not be count for delivery period and si te not ready/ site not handed over will not be count for installation period.
- 13. Inspection: The pre delivery inspection will be carried out by third party Inspection agency viz LLOYDS/SGS /Bureau Veritas/ TUV before shipment of goods. (repeat of 9 pl delete)
  - 14. The purchaser's/consignee's contractual right to inspect, test and, if necessary, reject the g oods after the goods' arrival at the final destination shall have no bearing of the fact that the goods have previously been inspected and cleared by purchaser's inspector during pre-desp atch inspection mentioned above. "On rejection, the supplier shall remove such stores withi n 14 days of the date of intimation of such rejection from the consignee's premises. If such g oods are not removed by the supplier within the period mentioned above, the purchaser / co nsignee may remove the rejected stores and either return the same to the supplier at his risk and cost by such mode of transport as purchaser / consignee may decide or dispose of such goods at the supplier's risk to recover any expense incurred in connection with such disposal s and also the cost of the rejected stores if already paid for." Goods accepted by the purchas er/consignee and/or its inspector at initial inspection and in final inspection in terms of the co ntract shall in no way dilute purchaser's/consignee's right to reject the same later, if found de ficient in terms of the warranty clause of the contract.
- 15. If a firm quoted **NIL charges** the bid shall be treated as unresponsive and will not be considered.
- 16. To assist in the examination, evaluation and comparison of Bids the HSCC may, at its discretion, as k the Bidder for clarification (i.e., historical data on past performance) of its Bid. Bidder shall be give n only **5 working days** to provide the required clarification/ details/documents etc. In case all the re quired clarification/ details/documents are still not provided the final reminder to the bidder intimati ng the pending clarification/ details/documents will be given and the bidder shall submit the required clarification/ details/documents **within 4 working days**. After the final reminder if still the required documents are not submitted, the bid will be evaluated based on the documents submitted by the bidder and the contents of the bid.
  - 17. The following are some of the important aspects, for which a tender shall be declared non- responsive and will be summarily ignored.

(i) Bidder/ Tenderers who are deregistered/banned/blacklisted/put on holiday list by a ny Govt. Authorities at the time of issuance NOA.

(iii) Amount and validity period of EMD is short.

(iv) If CMC not quoted by bidder.

#### AWARD OF CONTRACT

- 18. **Purchaser's Right to accept any tender and to reject any or all tenders:** HSCC on behalf of the Purchaser reserves the right to accept in part or in full any tender or reject any or more tender(s) or to cancel the tendering process and reject all tenders at any time prior to award of contr act, without incurring any liability, whatsoever to the affected tenderer or tenderers.
- 19. Variation of Quantities at the Time of Award/ Currency of Contract: At the time of awarding the contract, HSCC on behalf of the purchaser reserves the right to increase or decrease up to twent y five (25) per cent, the quantity of goods and services mentioned in the schedule (s) in the "List of Requirements" (rounded off to next whole number) without any change in the unit price and other t erms & conditions quoted by the tenderer.

If the quantity has not been increased at the time of the awarding the contract, the HSCC on behalf o f the purchaser reserves the right to increase by up to twenty five (25) per cent, the quantity of goo

ds and services mentioned in the contract (rounded off to next whole number) without any change i n the unit price and other terms & conditions mentioned in the contract, during the currency of the c ontract within one year from the Date of Notification of Award.

- 20. Notification of Award: The successful Bidder/tenderer must furnish to the purchaser the required performance security within fifteen (15) days from the date of the notification of award. The Notifi cation of Award/Supply order from date of issue shall constitute the conclusion of the legally binding Contract. The Notification of Award/ Supply order will be placed on successful bidder (i.e., manufactur re and /or manufacture authorized agent). The manufacturer and /or manufacture authorized agent shall be jointly and severally liable to perform all the contractually obligations und er the agreement.
  - 21. Performance Security shall be in favour Director, Lady Hardinge Medical College & Associated Hospitals (LHMC), New Delhi furnish by the supplier as per the tender docum ent terms& condition within fifteen (15) days from date of the issue of notification of award for an amount equal to three percent (3%)[ as per DoE OM no. 9/4/2020-PPD dt. 12.11.2020] of the total value of the contract valid up to sixty (60) days after the date of completion of all contractual obligations by the supplier, including the warranty obligations i.e. Initially valid for r a period of minimum 67 months from the date of Notification of Award, failing which Noti fication of Award shall be declared null and void, supplier have no right for any claim and HS CC will forfeited bid security/EMD / may recommend the Purchaser/GeM to blacklist the supplier for the period of next 6 months to participate in the future bid floated by Purchaser directl y or indirectly.
- 22. **Contract:** The Notification of Award shall constitute the conclusion of the Contract. The Notification of Award/ Supply order shall constitute the conclusion of the Contract agreement from date of issue.
  - 23. **Subcontracts:** The Supplier shall take prior consent in writing of the Purchaser through H SCC in writing of all sub contracts to be awarded under the contract. Such subcontracting, sh all not relieve the Supplier from any of its liability or obligation under the terms and condition s of the contract.
  - 24. **Modification of contract:** If necessary, the HSCC on behalf of the purchaser may, by a wri tten order given to the supplier at any time during the currency of the contract, amend the co ntract by making alterations and modifications within the general scope of contract in any on e or more of the following:
    - a) Specifications, drawings, designs etc. where goods to be supplied under the contract are to be specially manufactured for the purchaser,
    - b) Mode of packing,
    - c) Incidental services to be provided by the supplier
    - d) Mode of despatch,
    - e) Place of delivery, and
    - f) Any other area(s) of the contract, as felt necessary by the purchaser depending on t he merits of the case.

In the event of any such modification/alteration causing increase or decrease in the cost of goods and services to be supplied and provided, or in the time required by the supplier to per form any obligation under the contract, an equitable adjustment shall be made in the contract t price and/or contract delivery schedule, as the case may be, and the contract amended acc ordingly. If the supplier doesn't agree to the adjustment made by the Purchaser/Consignee, t

he supplier shall convey its views to the Purchaser/Consignee within twenty-one days from th e date of the supplier's receipt of the Purchaser's/Consignee's amendment / modification of t he contract.

- 25. **Dispatch Clearance for goods**: To issue dispatch note, supplier/manufacture is to furnish the foll owing documents in **original hard copy to HSCC office and soft copy by email:**

  - h. Inspection report with photo of equipment by third party inspection agency viz SGS/ Lloyd/ Bureau Veritas/ TUV and all pages of this report duly signed & stamped by insp ector of said agency prior to dispatch.

All above documents (a to h) should mention contract number, goods description, make & model of equipment. The Invoice should be in favour of **Director, Lady Hardinge Me dical College &Associated Hospitals (LHMC), New Delhi** through HSCC (India) Limit ed. After scrutiny, if the documents found in order, **dispatch note** will be issued to the s upplier.

No goods shall be dispatched before issue of dispatch note issued by HSCC, failing which responsibility shall be rest on manufacture/supplier.

- 26. The Invoice of equipment shall be in favour of **Director, Lady Hardinge Medical College & Ass** ociated Hospitals (LHMC), New Delhi through HSCC (India) Limited. The payment to the supplier will be made by LHMC or through HSCC for and on behalf of LHMC from the fund of LHMC available with HSCC (India) Limited for the goods, . HSCC shall not personally liable for any liabilities including but not limited to the payment to the Supplier under the contract.
- 27. **Warranty: Five years Site Comprehensive Warranty** from the date of installation & commissio ning and handing over the equipment to LHMC. In case of any claim arising out of this warranty, the Purchaser/Consignee shall promptly notify the same in writing to the supplier.

Upon receipt of such notice, the supplier shall, within 8 hours on a 24(hrs) X 7 (days) X 365 (days) basis respond to take action to repair or replace the defective goods or parts thereof, f ree of cost, at the ultimate destination. The supplier shall take over the replaced parts/goods after providing their replacements and no claim, whatsoever shall lie on the purchaser for suc h replaced parts/goods thereafter. The clause for non-rectification defective goods or parts th ereof will be applicable as per tender conditions.

In the event of any rectification of a defect or replacement of any defective goods during th e warranty period, the warranty for the rectified/replaced goods shall be extended till the co mpletion of the original warranty period of the main equipment.

If the supplier, having been notified, fails to respond to take action to repair or replace the defect(s) within 8 hours on a 24(hrs) X 7 (days) X 365 (days) basis, the purchaser may proce ed to take such remedial action(s) as deemed fit by the purchaser, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which the purch

aser may have against the supplier.

During Warranty period, the supplier is required to visit at each consignee's site at least on ce **in 6 months** commencing from the date of the installation for preventive maintenance of the goods. **98% up time** Warranty of complete equipment with extension of Warranty perio d by double the downtime period on 24 (hrs) X 7 (days) X 365 (days) basis. All software upda tes should be provided free of cost during Warranty period.

After sales service center should be available at the city of Associated Hospitals/Ins titution/Medical College on 24 (hrs.) X 7 (days) X 365 (days) basis. Complaints should be atte nded properly, maximum within 8 hrs. The service should be provided directly by Tenderer/I ndian Agent. Undertaking by the Principals that the spares for the equipment shall be availab le for at **least 10 years from the date of supply**.

#### 28. Comprehensive Maintenance Contract (CMC):

The supplier along with its Indian Agent and the CMC provider shall ensure continued supply of the spare parts for the machines and equipment supplied by them to the purchaser **for 10 years** from the date of installation and handing over.

29. **Turnkey:** Turnkey is indicated in the technical specification of the respective items, wherev er required. The Tenderer shall examine the existing site where the equipment is to be install ed, in consultation with HOD of Associated Hospitals/Institution/Medical College concerned. T

urnkey details of each are given at the end of Technical Specification. The Tenderer to quote prices indicating break-up of prices of the Machine and Turnkey Job of each Associated Hospi tals/Institution/Medical College. **The Turnkey costs may be quoted** all-inclusive lump sum price **in Indian Rupee will be added for Ranking Purpose.** The taxes to be specifically st ated. In the absence of any such stipulation the price will be taken inclusive of such duties a nd taxes and no claim for the same will be entertained later. The Turnkey Work should compl etely comply with AERB requirement, if applicable.

For turnkey work room will be available in unfinished condition. Therefore Bidders shall visi t the LHMC Delhi to assess the site condition of room wherein equipment is to be placem New ent and installed Bidders must take into consideration in its bid costs to b before quote. e incurred for any additional work/modification viz. Electrical cabling of suitable ratings, Electri cal points of suitable ratings, water connection, civil work, site modification, water drain equipment etc. requi age, UPS, air condition, fire fighting, plumbing & allied requirement for the red for successful installation, commissioning and running of the Equipment and the "All inclu sive lump sum price" should include all such costs.

- b. **20 % On Acceptance:** Balance payment of **20 %** Goods would be made against 'Fi nal Acceptance Certificate' to be issued by the consignees/HSCC to the supplier
- c. **Payment of Turnkey, if any:** . Turnkey payment will be made to the supplier on pr o-rata basis against work done certified by consignees/HSCC.
- d. **Payment for Annual Comprehensive Maintenance Contract Charges:** The c onsignee may enter into CMC with the supplier at the rates as stipulated in the contra ct. The payment of CMC will be made on **six monthly basis after satisfactory co mpletion of said** period, duly certified by the consignee on receipt of bank guarante

e for an amount equivalent to 2.5 % of the cost of the equipment as per contract in th e prescribed format valid till 2 months after expiry of entire CMC period.

- 31. The no interest on delayed payments under the contract is payable
- 32. **Liquidated Damage**: If the supplier fails to deliver any or all the goods or fails to perform t he services within the time frame(s) incorporated in the contract, the Purchaser/Consignee or through HSCC (India) Limited shall, without prejudice to other rights and remedies available t o the Purchaser/Consignee under the contract and/or in law, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delay ed supply of goods and/or services until actual delivery or performance subject to a maximu m of 10% of the contract price. Once the maximum is reached Purchaser/Consignee may con sider termination of the contract. Liquidated damages will be adjusted from the final bill 20% payment delay on supply, Installation & commissioning.
- 33. **Resolution of disputes:** If dispute or difference of any kind shall arise between the Purch aser / Consignee and the supplier in connection with or relating to the contract, the parties s hall make every effort to resolve the same amicably by mutual consultations. The award of the arbitrator shall be final and binding on the parties to the contra ct subject to the provision that the Arbitrator shall give reasoned award. Venue/seat of Arbitr ation: shall be at **New Delhi, India.**
- 34. **Applicable Law and Jurisdiction:** The contract shall be governed by and interpreted in ac cordance with the laws of India for the time being in force. The contract shall be subject to th e jurisdiction of Delhi court to the exclusion of all other courts.
- 35. Notwithstanding the above, the Purchaser reserves the right to accept or reject any bid and to cancel the bidding process and reject all bids at any time prior to the award of contract.
- 36. Insurance: (i) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entire stores contracted for arrival in good condition at destination. The transit r isk in this respect shall be covered by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee. (ii) If the equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be got extended by the supplier at their cost till the successful installation, testing, commissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the supplier, but the insurance extension charges at actual will be reimbursed. AND WHEREAS the Purchaser values full compliance with all relevant laws of the land, rules, regula tions, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Supplier(s). AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter in to this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and co nditions of which shall also be read as integral part and parcel of the Tender/Bid document s and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

Article 1: Commitment of the Purchaser

- (1) The Purchaser commits itself to take all measures necessary to prevent corruption and to ob serve the following principles:
  - (a) No employee of the Purchaser personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promis e for or accept, for self or third person, any material or immaterial benefit which the pe rson is not legally entitled to.
  - (b) The Purchaser will, during the Tender process, treat all Bidder(s) with equity and reason. The Purchaser will, in particular, before and during the Tender process, provide to all Bi dder(s) the same information and will not provide to any Bidder(s) confidential / additio nal information through which the Bidder(s) could obtain an advantage in relation to th e Tender process or the Contract execution.
  - (c) The Purchaser shall endeavor to exclude from the Tender process any person, whose co nduct in the past has been of biased nature.
- (2) If the Purchaser obtains information on the conduct of any of its employees which is a crimin al offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantiv e suspicion in this regard, the Purchaser will inform the Chief Vigilance Officer of the Purcha ser and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: Commitment of the Bidder(s)/Supplier(s)

(1) It is required that each Bidder/Supplier (including their respective officers, employees and ag ents) adhere to the highest ethical standards, and report to the Government / Department a Il suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or aw ard of a contract.

- (2) The Bidder(s)/ Supplier (s) commits himself to take all measures necessary to prevent corrup tion. He commits himself to observe the following principles during his participation in the T ender process and during the Contract execution:
  - (a) The Bidder(s)/ Supplier (s) will not, directly or through any other person or firm, offer, pr omise or give to any of the Purchaser's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any ki nd whatsoever during the Tender process or during the execution of the Contract.
  - (b) The Bidder(s)/ Supplier (s) will not enter with other Bidder(s) into any undisclosed agree ment or understanding, whether formal or informal. This applies in particular to p rices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding pro cess.
  - (c) The Bidder(s)/ Supplier (s) will not commit any offence under the relevant IPC/PC Act. Fur ther the Bidder(s)/Contractor(s) will not use improperly, (for the purpose of competitio n or personal gain), or pass on to others, any information or documents provided by the Purchaser as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - (d) The Bidder(s)/ Supplier (s) of foreign origin shall disclose the names and address es of agents/ representatives in India, if any. Similarly Bidder(s)/ Supplier (s) of Indian N ationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a ten der on behalf of one manufacturer, he shall not be allowed to quote on behalf of anothe r manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
  - (e) The Bidder(s)/ Supplier (s) will, when presenting his bid, disclose any and all payments h e has made, is committed to or intends to make to agents, brokers or any other interm ediaries in connection with the award of the Contract.
- (3) The Bidder(s)/ Supplier (s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (4) The Bidder(s)/ Supplier (s) will not, directly or through any other person or firm indulge in fra udulent practice means a willful misrepresentation or omission of facts

or submission of fake/forged documents in order to induce public official to act in reliance t hereof, with the purpose of obtaining unjust advantage by or causing damage to justified i nterest of others and/or to influence the procurement process to the detriment of the Government interests.

(5) The Bidder(s)/ Supplier (s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a deci sion through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

#### Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Purchaser under law or the Contrac t or its established policies and laid down procedures, the Purchaser shall have the following rig hts in case of breach of this Integrity Pact by the Bidder(s)/ Supplier (s) and the Bidder/ Supplier accepts and undertakes to respect and uphold the Purchaser's absolute right:

(1) If the Bidder(s)/ Supplier (s), either before award or during execution of Contract has commit

ted a transgression through a violation of Article 2 above or in any other form, such as to pu t his reliability or credibility in question, the Purchaser after giving 14 days' notice to the Su pplier shall have powers to disqualify the Bidder(s)/ Supplier (s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/ Supplier from future contract award processes.

The imposition and duration of the exclusion will be determined by the severity of transgres sion and determined by the Purchaser. Such exclusion may be forever or for a limited period as decided by the Purchaser.

- (2) Performance Guarantee/Security Deposit: If the Purchaser has disqualified the Bidder(s) f rom the Tender process prior to the award of the Contract or terminated/determined the Co ntract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Purchaser apart from exercising any legal rights that may have accrued to the Pur chaser, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, P erformance Guarantee and Security Deposit of the Bidder/Supplier.
- (3) Criminal Liability: If the Purchaser obtains knowledge of conduct of a Bidder or Supplier, or o f an employee or a representative or an associate of a Bidder or Supplier which constitutes corruption within the meaning of IPC Act, or if the Purchaser has substantive suspicion in thi s regard, the Purchaser will inform the same to law enforcing agencies for further investigat ion.

#### Article 4: Previous Transgression

- (4) Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original i ntentions.

6.While creating a bid or RA, buyers shall indicate whether CMC is required against Yes/No" options. If CMC Charges are included, an option for number of years for CMC required after the warranty period shall be available.Under this option up to 10 years can be chosen for CMC charges beyond warranty period.

7.In case the bid has a provision for CMC, the warranty of the product will also be deemed to have been converted into Comprehensive warranty including preventive maintenance and calibration as per technical/ service /operational manual of the manufacturer, service charges and spares, during the Warranty Period also. Sellers are therefore advised to include the cost of Comprehensive Warranty including spares (excluding consumables) also in product Cost.

8.The CMC functionality shall be available in bid only and no direct RA shall be applicable.In case of bid to R/A decrement rules shall be applicable on total price inclusive of CMC charges. Bunching of products shall not be available while creating bids with CMC charges.

8.1.Buyer shall indicate number of years of warranty by selecting different options available in the field depending on warranty parameter applicable in category parameters for the equipment. No. of years of warranty indicated here shall supersede the warranty period indicated elsewhere in bid or product specifications. The Seller while participating in Bid/RA will get fields to indicate CMC charges as percentage depending on number of years of CMC selected by Buyer. The following shall be applicable, if 5 year CMC selected:

CMC charges for 1st year after warranty period- Percentage to be indicated- A1

CMC charges for 2nd year after warranty period- Percentage to be indicated- A2

CMC charges for 3rd year after warranty period – Percentage to be indicated- A3

CMC charges for 4th year after warranty period – Percentage to be indicated- A4

CMC charges for 5th year after warranty period – Percentage to be indicated- A5

Similarly, A6 to A10 are to be indicated for 6th to 10th year of CMC if applicable.

8.2. The calculation of CMC Charges shall take into account the number of years of warranty and duration of CMC as specified while creating bid.

8.3.In the price evaluation, the system shall provide function to calculate the cost of each equipment by formula indicated below includingCMC and then show the inter-se-ranking of the bidders. The following are the variables

(i) Number of years for which CMC required.

(ii) Number of years of product warranty

The formula for calculating total cost including CMC charges shall be as under:

Total Cost for evaluation=

 $C+C^{(A1/100)/(1.10^n)+(A2/100)/(1.10^n+1)+(A3/100)/(1.10^n+2)+(A4/100)/(1.10^n+3)+(A5/100)/(1.10^n+4)}$  and so on

C – Cost for equipment quoted and n shall be number of years of product warranty specified.

If 2 year warranty specified, n shall be2 and if 5 year warranty specified, n shall be 5. A1,A2, A3, A4& A5shall depend on how many years CMC selected. For3 yearCMC, only A1,A2 and A3 factors are to be taken into account and A4 and A5 will not be applicable.

8.4.CMC charges offered for each subsequent year should be same or higher than preceding year.

8.5. The CMC charges shall be offered within range of 3 to 10% of cost of equipment.

9.Since CMC charges are to be paid only later for each year during CMC period, applicable performance guarantee amount after placement of contract shall be based on the cost of equipment excluding the cost of CMC Charges. 10.Performance bank guarantee applicable for CMC is to be submitted at start of the CMC and shall be applicable between 2.5% to 5% as specified in bid on total CMC Charges. The PBG submitted after award of contract shall be released only after new PBG for the CMC period is submitted and accepted by buyer/consignee after due verification.Bank guarantee for CMC is to remain valid till completion of CMC period plus one year. The bank guarantee for CMC shall be submitted to buyer directly. In case, seller fails to submit the PBG or does not provide services for the CMC contract after expiry of warranty period then PBG of equipment shall be forfeited. 11.In case of splitting of order quantity, equipment cost and CMC charges offered by L1 bidder shall be matched by

higher quoting eligible bidders on one-to-one basis. The equipment cost and CMC charges (year to year) shall be matched individually.

12. The CMC Contract shall be an offline contract to be handled by buyer. The payment of CMC will be made on quarterly basis after satisfactory completion of said period, duly certified by end user and scope of CMC will be as per para 1 above.

13.CMC Charges are inclusive of all the charges for Transportation, Lodging, Boarding, all insurances including third party insurance and all other incidental charges. The same shall include GST. The prices also include cost of spares and damaged parts. Purchaser does not have any liability, whatsoever, over and above the cost of CMC. It also includes for arranging hand tools & tackles, special tools etc. required to carry out the work.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
