In case, at any stage, any of the information/ document is found to be false/ material not found as per technical specification mentioned in the bid document, the Purchaser /consignee shall have full right to reject bid/ cancel the purchase order and / or stop payment / recover the liabilities, if any from balance pay ment / forfeit performance security etc.
