- Contract value more than 3.0 Cr. : Supplier will submit 3 RA bill & Final

10. Bidders /OEM should upload an affidavit ( as per attached format I ) on Non-Judicial stamp paper of Rs. 100/- that the bidder has never been blacklisted / de-listed or debarred for any of the furniture supply by any Central Government/ State Government/ Semi Government/ PSU /Banks /Universities / Educational Institute/Autonomous body.
