#### 3.3 Financial Evaluation

- i. Evaluation Committee shall open the financial Bid of the technically qualified Bidders in the presence of the Bidders/their authorized representative, who choose to attend, at the scheduled date and time.
- ii. On opening the financial Bids, the Evaluation Committee shall read out the financial Bid to all the Bidders and note the same.
- iii. The Evaluation Committee shall correct arithmetic errors, if any and sign the same.

#### **Conditions:**

- 1. Location of work: Post Graduate Institute of Medical Education & Research (PGIMER), Sector-12, Chandigarh.
- 2. The pre-decided routes within PGIMER Chandigarh campus shall only be allowed for carriage of reinforcement steel. The agency shall apply for passes for movement of dumpers/ trucks & equipments and provide the registration no. of the said vehicles.
- 3. Any damage to the existing building/ structure/ fencing/ wiring/ sewer lines/ water lines/ telephone cables/ power cables etc during carriage of steel or otherwise shall be rectified/ made good by the agency.
- 4. Work must be completed in **10 days** in all respects.
- 5. The Bid document fee is **Rs.1000/- (Rs. One Thousand Only)** (non-refundable) payable in the form of Demand Draft in favour of *HSCC (India) Ltd.* payable at New Delhi/Noida. The bidder should submit the Bid document fee as above along with bid security / EMD the Bid in Envelope No.1.
- 6. EMD / Bid Security (Earnest money) is **Rs. 2.0 Lacs. (Rupees Two Lacs only)** in form of the bank draft drawn in favour of "*HSCC (INDIA) LIMITED*" Payable at **Noida/New Delhi** should accompany the Bid. Earnest Money in any other form will not be accepted.
- 7. The EMD / Bid Security of successful bidder shall be released after successful completion of work.
- 8. The bidders are advised in their own interest to visit the site before quoting rates.

- 13. Agency shall be responsible for the payment of all royalty, if any, as applicable and Director, PGIMER, Chandigarh / HSCC shall not be responsible.
- 14. Work shall be carried out manually and by mechanically means to ensure timely completion as per direction of Engineer-in-charge.
