**Name of Work: Sale of dismantled SCRAP lying at 2<sup>nd</sup> floor of CN centre, AIIMS, New Delhi.**

**Conditions & Instructions to Bidders:-**

1. The removal of SCRAP work must be completed in 7 days in all respects.
2. Earnest money Rs 10,000.00 (Rs Ten thousand only) in form of bank Draft drawn in favour of HSCC INDIA LTD. Payable at Noida/New Delhi should accompany the bid. Earnest money in any other form will not be accepted.
3. Envelop No.-1 should contain the demand draft of Bid security and tender documents fee (as applicable) & on the top of envelop it should be clearly marked as "Envelop No-1" contains Bid security and Tender Documents.
4. Envelop no.-2 should contain price bid & clearly marked as "Envelop No.-2" contains Price Bid only
5. All the above Two Envelops (Envelop No.-1 & Envelop No.-2) duly sealed & should be placed in the "Envelop No.-3" and Marked Name of Tender & No. and also Name & Address of Bidder.
6. The bidder should quote rate in percentage above/below the reserve price mentioned in bill of quantities.
7. The bidder shall, within 7 days of receipt of the intimation of acceptance of his bid by HSCC, pay to HSCC (I) Ltd by demand draft drawn in favour of HSCC (I) Ltd Payable at Noida, the full amount of the bid, where upon he shall take the possession of SCRAP material and give a receipt to the office of Superintending Engineer, AIIMS, New Delhi. No removal of SCRAP shall take place before such payment is made and receipt given to the office of Superintending Engineer, AIIMS, New Delhi. In case the contractor/firm/individuals fail to deposit the bid amount within 7 days, the earnest money shall stand forfeited.
8. Removal of SCRAP work shall be carried out manually and by mechanically means to ensure timely completion as per direction Engineer-in-charge.
9. In case the demolition work is not completed in all respects by the agency in 7 days, a penalty will be imposed @**Rs.1000/-** per day (subject to maximum amount of EMD) & shall be recovered from the earnest Money deposited.
10. Sale Tax and other taxes as applicable will be paid by the bidder separately along with the bid amount.
11. Contractor/firms/individuals are requested to visit to at 2<sup>nd</sup> floor of CN Centre and assess the material stocked there before quoting their rates. The bidder shall be deemed to have full knowledge thereof and shall have no claims on account of any shortage of materials etc.
12. The Bidder shall be responsible for any damage during the removal of SCRAP and indemnify the HSCC/ AIIMS against any claim on account thereof including the third party and workmen's compensation claims. If damage is done to the said property or any other adjoining property, AIIMS shall be entitled to have the same made good at the risk and cost

of the bidder to treat default as a sufficient ground for terminating the contract and forfeiting the entire earnest money as well as the bid amount therefore.

13. The tenderer shall acquire no interest in the land bearing the said property except a license to enter thereon for removal of material.
14. If the tenderer fails to observe or perform any provision of the contract or become insolvent or make arrangement with creditor, the Engineer-in-charge may terminate the contract without notice prejudice to his right to claim any other loss there by incurred.
15. The conditional bids will be rejected out right.
16. HSCC /AIIMS New Delhi reserves in himself the authority to reject / or all the bids without assigning any reason therefore.
17. It may be made clear that no payment will be made to the bidder for removal of the SCRAP material (including clearance of the site as per the instruction of the Engineer-in-charge) shall be taken into account by the bidder while quoting the amount to be paid to HSCC for Entire Work.
18. If any dispute arises in connection with execution of the contract, the same shall be referred to Director, AIIMS, New Delhi and his decision shall be final and binding on both the parties.
19. The bidder should sign every page of the bid form and amount to be paid in words and figures, both.
20. The bidders are advised in their own interest to visit the site before quoting rates.
21. The bidder should sign on all the pages of bid documents.
