1. GENERAL

1.1 NEED

In view of increasing demands including patients of the institution, there is a need to expand infrastructure of present campus of Safdarjung Hospital, New Delhi. In expansion plan two block namely Emergency Block and Super Speciality Block (SSB) are upcoming.

In Emergency Block there are 500 Beds including 15 major OTs, Two minor OTs and 90 Bedded ICUs. In Super Speciality Block there are 807 Beds including 20 OTs, ICU (125 bedded) and 228 Bedded private ward. In view of increasing demands including patients of the institution, there is a need for 2 Stage Car Parking including Parking Management System for more than 1216 Cars for Emergency & Super Speciality Block.

The new blocks Safdarjung is expected to provide top quality state of the art superspecialty healthcare and will train medical graduates and post-graduates with international levels of quality and efficiency in health care delivery.

2. ROLE/SCOPE OF WORK
