#### 1. **BID Documents**:

#### 1.1 Contents of BID Documents

#### 2.1 Preparation of Bid:

- a) Bidder's responsibility:
  - i. The Bidder is solely responsible for the details of his Bid and the preparation of Bids.
  - ii. The Bidder is expected to examine carefully all the contents of BID document as mentioned in Notice Inviting Bids including instructions, conditions, forms, terms, etc and take them fully into account before submitting his offer. Bids, which do not satisfy all the requirements, as detailed in these documents, are liable to be rejected as being unresponsive.

#### 2.3.1 Language of Bid

The Bid and all related correspondence and documents relating to the Project shall be in English language.

#### 2.4.1 <u>Currency of Bid</u>

Bid prices shall be quoted in Indian Rupees only. The amount mentioned elsewhere in the bid document will also deemed to be in Indian Rupees unless otherwise mentioned.

#### 2.5.1 Extension of Bid Validity

Prior to the expiry of the original Bid Validity Period, DGMER/ HSCC may, at its discretion, request Bidders to extend the Bid Validity Period for a specified additional period and also correspondingly extend the period of validity of Bid Security submitted in the form a Bank Guarantee.

#### 2.6.1 Format and Signing of Bid

- a. Bid documents (technical package/ bid Part I and financial package/ bid) shall be digitally signed by a person duly authorized to sign the Bid documents. The Bidder shall also submit a power of attorney authorizing the person signing the documents.
- b. Entries to be filled in by the Bidder shall be typed or written in indelible ink.
- c. The complete Bid shall be without alterations, overwriting, interlineations or erasures except those to accord with instructions issued by DGMER, Punchkula, Haryana/ HSCC, or as necessary to correct errors made by the Bidder. All amendments/corrections shall be initialed by the person or persons signing the Bid.
- d. All witnesses and sureties shall be persons of status and probity and their full names, occupations and addresses shall be written below their signatures.

#### 2.7.1 Sealing and Marking of Bids

#### 2.8.1 **Submission of Bids**

- i. The last date for submission of completed Bids is given in Notice Inviting Bids. The DGMER/ HSCC may, at their discretion, extend this date, in which case all rights and obligations of the DGMER, Panchkula, Haryana and the Bidder shall thereafter be subjected to the new deadline as extended. If such nominated date for submission of Bid is subsequently declared as a public holiday, the next official working day shall be deemed as the date for submission of Bid.
- ii. - iv. Modifications/ Substitution/ Withdrawal of Bids
  - (a) No modification or substitution of the submitted Bid shall be allowed after last date of submission of bids.
  - (b) A Bidder may withdraw its submitted Bid, provided that written notice of the withdrawal is received by DGMER, Panchkula, Haryana/ HSCC before the last date for submission of Bids.
  - (c) Only a single copy of the withdrawal notice shall be prepared and each page of the notice shall be signed and stamped by the authorized signatory. The notice shall be duly marked "WITHDRAWAL". This withdrawal notice will be opened at the time of opening of bid and not earlier. The signature of GPA holder will be verified and withdrawal shall be considered only in case both are same.

#### v. Bid Due Date

- a. Bids should be received at the address mentioned in this document, on or before the stipulated/extended time and date as specified in Notice Inviting Bids.
- b. HSCC/ DGMER may, in exceptional circumstances, and at its sole discretion, extend the Bid due date by issuing an addendum.

#### vi. Late Bids

Any Bid received at the address mentioned above after the deadline prescribed for submission of Bids in Notice Inviting Bids/extended date as the case may be, herein will not be considered and will be returned unopened to the Bidder.

#### 2.9.1 Power of Attorney:

Bidders shall submit, along with Technical Package - Part II, a power of attorney, on a stamp paper of appropriate value , in favour of the person signing the Bid documents authorizing him to sign the Bid documents, make corrections/modifications thereto and interacting with DGMER, Panchkula, Haryana/HSCC and act as the contact person. #### **EVALUATION PROCESS**

#### 3.1 Evaluation Process:

The Bids will be evaluated in the following stages:

**3.2** Financial Bid of those Bidders who have submitted the requisite documents shall be opened.

#### 3.3 Financial Evaluation

- i. Evaluation Committee shall open the financial Bid of the technically qualified Bidders in the presence of the Bidders/their authorized representative, who choose to attend, at the scheduled date and time.
- ii. On opening the financial Bids, the Evaluation Committee shall read out the financial Bid to all the Bidders and note the same.
- iii. The Evaluation Committee shall correct arithmetic errors, if any and sign the same.
- iv. All the financial Bids shall then be ranked according to the financial Bid in decreasing order with the Bidder quoting the Highest amount shall be ranked H1, Bidder quoting next Lower figure as H2 and so on.
- v. H1 will be declared as Successful Bidder and his offer will be processed further.
- vi (a)The financial bid of all eligible bidders as decided by Client shall be opened and the decision of Client will be final and binding.
  - (b) The date and time of opening of financial bids shall be decided by Department which will be intimated at an appropriate time

#### 3.4 Letter of Award:

The Successful Bidder would be notified in writing by Client/ HSCC by issuing the Letter of Award (LOA) in favour of the Bidder.

# TERMS AND CONDITIONS FOR "Disposal of surplus excavated earth outside from the Hospital premises of KCGMC, Karnal"

#### **Conditions:**

- 1. Location of works: KCGMC (Kalpana Chawla Govt. Medical College) at Karnal.
- 2. The pre-decided routes within KCGMC campus shall only be allowed for carriage of earth. The agency shall apply for passes for movement of dumpers/ trucks & equipments and provide the registration no. of the said vehicles.
- 3. Any damage to the existing building/ structure/ fencing/ wiring/ sewer lines/ water lines/ telephone cables/ power cables etc during carriage of earth or otherwise shall be rectified/ made good by the agency.
- 4. The disposal work must be completed in 45 days in all respects.
- 5. The Bid document fee is **Rs.1000/-** (**Rs. One Thousand Only**) (non-refundable) payable in the form of Demand Draft in favour of *HSCC* (*India*) *Ltd.* payable at New Delhi/Noida. The bidder should submit the Bid document fee as above along with bid security / EMD the Bid in Envelope No.1.
- 6. EMD / Bid Security (Earnest money) is **Rs. 2.0 Lacs.** (**Rupees Two Lacs only**) in form of the bank draft drawn in favour of "*HSCC (INDIA) LIMITED*" Payable at **Noida/New Delhi** should accompany the Bid. Earnest Money in any other form will not be accepted.
- 7. The EMD / Bid Security of successful bidder shall be released after successful completion of work.
- 8. The bidder should quote total credit to be given to Kalpana Chawla Government Medical College.
- 9. The Bidder shall, within 7 days of receipt of the intimation of acceptance of his bid by HSCC pay to Director, Kalpana Chawla Govt. Medical College, Karnal, Haryana by demand draft drawn in favour of "Director, Kalpana Chawla Govt. Medical College" Payable at Karnal, the full amount of the bid, where upon he shall take the possession of the earth for disposal and give credit receipt to the office of Director, Kalpana Chawla Govt. Medical College. No disposal of earth shall take place before such payment is made and receipt given to the office Director, Kalpana Chawla Govt. Medical College. In case the contractor fails to deposit the bid amount within 7 Days, the earnest money shall stand forfeited.
- 10. Disposal work shall be carried out manually and by mechanically means to ensure timely completion as per direction of Engineer-in-charge.

- 11. In case the disposal work is not completed in all respect by the agency in 45 days, a penalty will be imposed @Rs.5000/- per day (Subject to maximum amount of EMD) & shall be recovered from the earnest Money deposited.
- 12. The quoted rates shall be deemed to include all statutory taxes, royalty, cess and any other applicable statutory requirement. Agency shall be responsible for the payment of all royalty, if any, as applicable and DGMER / HSCC shall not be responsible
- 13. The agency shall be responsible for and comply all safety measures, labour regulations, traffic rules & timings etc
- 14. In case HSCC/DGMER is not satisfied with the performance of agency or progress of works, HSCC has the right to cancel the work order and forfeit agency's bid security and security deposit. The agency shall not be entitled for any compensation.
- 15. The Bid shall remain valid and open for acceptance for a period of 120 days from the last date of submission of the Bid as per the Bid Documents or any extension thereto
- 16. The tenderer may visit at site & access the actual quantity of earth to be disposed.
- 17. HSCC/DGMER, Panchkula, Haryana reserves in himself the authority to allow disposal of only one of the heaps mentioned above or both the heaps mentioned above, without assigning any reason therefore. However in case of retaining one of the heap by HSCC/DMER, the credit amount deposited by the bidder for that particular heap shall be refunded to the bidder.
- 18. For all legal matters relating to and arising out of above works, the jurisdiction shall be that of the civil courts at Chandigarh only.
- 19. Earth which is to be disposed has some construction debris mixed with it. The Tenderer shall be deemed to have full knowledge thereof and shall have no claims on account of any shortage of earth, composition of earth etc.
- 20. Earth shall be removed upto the level of internal road near labour ward of existing hospital and site shall be left & handed over back totally cleared/levelled as directed by Engineer-in-charge.
- 21. The Bidder shall be responsible for the damage during disposal operation and indemnify the HSCC/ Kalpana Chawla Govt. Medical College against any Claim on account thereof including the third party and workmen's compensation claims. If any damage is done to the said property or any other adjoining property, Director, Kalpana Chawla Govt. Medical College (Client) shall be entitled to have the same made good at risk and cost of the bidder to treat default as a sufficient ground for terminating the contract and forfeiting the entire earnest money as well as the bid amount therefore.
- 22. During, disposal of earth from site, the tenderer shall maintain proper safety measures.

- 22. If the tenderer fails to observe or perform any provision of the contract or become insolvent or make arrangement with creditor, the Engineer-in-Charge may terminate the contract without notice prejudice to his right to claim any other loss there by incurred.
- 23. The conditional bids will be rejected outright.
- 24. HSCC/DGMER, Panchkula, Haryana reserves in himself the authority to reject/or the entire bid without assigning any reason therefore.
- 25. It may be made clear that no payment will be made by HSCC/ DGMER, Panchkula, Haryana to the bidder for removal of the earth (including clearance of the site as per the instruction of the Engineer-in-charge) shall be taken into account by the bidder while quoting the amount to be paid to Kalpana Chawla Govt. Medical College for entire work.
- 26. Any material of historical value discovered during the disposal of earth material shall belong to and shall be property of the Government of Haryana.
- 27. If any dispute arises in connection with the execution of the contract, the same shall be referred to the DGMER, Panchkula, Haryana and his decision shall be final and binding on both parties.
- 28. The highest bidder shall handover the site as cleared of all debris and levelled with respect to internal road level, to the satisfaction of Engineer-in-charge.
- 29. The bidders are advised in their own interest to visit the site before quoting rates.
- 30. The credit cost given must be taking into account all costs including loading, unloading, cartage, arrangement of trucks/waders, T&P charges, cost of earth & all applicable taxes, levies, permissions, etc.
