 - (ii) Experience should be in the name of bidding company and not in name of subsidiary/ associate company/ group company

Five *similar completed works costing not less than the amount equal to 20% of the estimated cost.

or

Four *similar completed works costing not less than the amount equal to 30% of the estimated cost.

or

Three *similar completed works costing not less than the amount equal to 40% of the estimated cost.

or

Two *similar completed works costing not less than the amount equal to 50% of the estimated cost.

or

One *similar completed work costing not less than the amount equal to 80% of the estimated cost.

* Similar works shall mean:

Construction of any RCC framed structure building including finishing complete, related internal services like plumbing & Electrical etc.

However, in case the bidder do not have the experience of major specialized works like plumbing, fire fighting, electrical & HVAC etc , such specialized works shall be carried out by specialized agencies having sound financial background and experience of executing works of similar nature & magnitude. - 3.3 The firm should submit an affidavit duly notarized that they have not abandoned any work of Union Government/ State Governments/ PSU's etc. during the last 5 years. They should also submit an affidavit that they have not been blacklisted, debarred, declared non performer or expelled by Union Government/ State Governments/ PSU's etc. during the last 5 years
- 3.4 The applicant should provide information regarding litigation/ Arbitration cases for the last five years as per ANNEXURE-V
- 3.5 Financial Capabilities: The Applicant should submit Audited Balance Sheets for the last three financial years i.e. 2010-11, 2011-12 & 2012-13. The applicant should not have incurred any loss in more than two years during the last five years ending 31st March 2013 (Fill enclosed ANNEXURE-III).

3.6 Minimum Solvency Requirement:

A solvency certificate from applicant's Bank (Nationalized/Scheduled) that applicant is solvent for 30% of the Project Estimated Cost. The certificate should be not more than one year old.
