Interested applicants/firms may see the complete set of tender documents which have been kept at dispatch counter of HSCC Corporate office, at E-6(A), sector-1, Noida. Contractors/firms may also purchase the complete set of tender documents comprising of Vol. I & II in person from the office of HSCC (I) Ltd, E 6A, Sector-1, Noida -201301 on any working day from 18.02.2012 to 23.02.2012 from 10.00 hrs to 16.30 hrs & upto 14.00 hrs on 24.02.2012 on written request mentioning the name & description of work against a non refundable fee of Rs. 100/- through Cash/demand draft in favour of HSCC (I) Ltd. **TERMS AND CONDITIONS FOR DISPOSAL OF SURPLUS EARTH FROM AIIMS  
CAMPUS, ANSARI NAGAR, NEW DELHI**

1. Location of works: Lady Hardinge Medical College & associated Hospitals, Shaheed Bhagat Singh Marg, Connaught Place, New Delhi.
2. The bids shall remain valid for a period of twenty days from the last date fixed for receiving the same.
3. The agency may visit the site before quoting for the works and shall be deemed to be familiar with the site conditions.
4. Earth shall be allowed to be disposed off in any number of installments as per decision of HSCC. In case of credit of amount to HSCC, 100% of amount, based on quoted rates by the agency, on account of installment of earth to be disposed shall be deposited to HSCC in the form of bank draft in favour of Lady Hardinge Medical College & Associated Hospitals, New Delhi payable at Delhi before taking up disposal of the said installment.
5. The pre-decided routes within LHMC campus shall only be allowed for carriage of earth. The agency shall apply for passes for movement of dumpers/ trucks & equipments and provide the registration no. of the said vehicles.
6. Any damage to the existing building/ structure/ fencing/ wiring/ sewer lines/ water lines/ telephone cables/ power cables etc during carriage of earth or otherwise shall be rectified/ made good by the agency.
7. The disposal of earth shall include loading, unloading of earth and shall be done by mechanical means only with sufficient number of such equipments including excavators, tipper/ dumpers and any other men & machinery to be deployed to remove and dispose the earth in stipulated time.
8. The estimated quantity of earth is tentative and may vary to any extent on plus or minus side. Any such variation shall not entitle the agency for any claims on account of it, whatsoever.
9. The quantity shall be measured in trucks for loose earth but shall not exceed the quantity of loose excavated earth at site, arrived at by increasing the volume of actual excavated earth by percentage of voids to be considered for loose earth as per CPWD specifications).
10. Works shall be completed within 30 days from the date of award of work.
11. The quoted rates shall be deemed to include all statutory taxes, royalty, cess and any other applicable statutory requirement. Agency shall be responsible for the payment of all royalty, if any, as applicable and LHMC / HSCC shall not be responsible

12. The agency shall be responsible for and comply all safety measures, labour regulations, traffic rules & timings etc.
13. Copy of their service tax registration and PAN no. shall be submitted by the agency along with the completed bid documents.
14. In case HSCC/LHMC is not satisfied with the performance of agency or progress of works, HSCC/LHMC has the right to cancel the work order and forfeit agency's bid security and security deposit. The agency shall not be entitled for any compensation from HSCC/LHMC.
15. For all legal matters relating to and arising out of above works, the jurisdiction shall be that of the civil courts at Delhi only.
16. The agency shall coordinate with existing contractor already engaged for excavation of earth and no claim, whatsoever, regarding re-handling of excavated earth shall be entertained.
17. The agency shall submit the bid security, tender document fee, PAN no., Service tax registration no., duly signed and stamped tender documents excluding price bid in sealed envelope marked "**Technical bid- Envelope no.1**". Price shall be submitted in a separate sealed envelope marked "**Price Bid- Envelope no. 2**". Both shall be sealed in a third envelope marked as "**Quotation for Disposal of earth from LHMC campus, New Delhi**".
